**LIABILITY RELEASE, INDEMNIFICATION, AND ASSUMPTION OF RISK**

I hereby agree to assume any and all risks associated with shooting at Pelham Fish and Game Club, Inc. **I understand Shooting is considered to be a dangerous activity and I assume the risk of any and all injuries I may suffer due to the physical condition of Pelham Fish and Game Club, Inc., equipment failures, acts of God, the acts or omissions of shooters or others who may be at, on, or near Pelham Fish and Game Club, Inc. whether with or without permission, and or for any other reason.**

I understand there will be other persons shooting, and/or carrying Firearms at Pelham Fish and Game Club, Inc. and I agree to act prudently and carefully to avoid causing them any injury. I certify that I am familiar with the use and operation of any firearms I may use while at Pelham Fish and Game Club, Inc. and I am familiar with the rules of shooting and firearm safety, as well as the specific shooting range rules of Pelham Fish and Game Club, Inc. (copies available).

I release the Pelham Fish and Game Club, Inc., their employees, agents, representatives, assigns, and members from any liability arising out of injuries or property damage I may suffer because of my presence at the Pelham Fish and Game Club, Inc., regardless of cause, including any which may be caused by my own or other's negligence.

I give this release and assume all the risks attendant therein in consideration of being allowed to enter onto, and shoot at, Pelham Fish and Game Club, Inc. If any portion of this release is found to be invalid, the offending portion shall be stricken and the remainder shall remain in full force and effect. I hereby agree that jurisdiction for this RELEASE shall lie exclusively in Hillsborough County, State of New Hampshire and shall be governed by the laws of the State of New Hampshire.

I hereby certify that I:

- (A) Have not been convicted of a felony that has not been annulled or expunged;
- (B) Have not been convicted of a violation of section 922 of title 18 [18 USCS § 922]; and
- (C) Am not a member of an organization that advocates the violent overthrow of the United States Government and that I am not barred by any law from the possession, use, or control of firearms.
